6a. STAND RENTAL CHARGE

- The basic rental charge for stands open only on one side is **200 euros (plus Spanish VAT)** per square metre. The charge for any fraction of a square metre will be charged as for a full square metre.
- The second storey of double storey stands will be charged at 50% of the basic rental charge i.e. **100 euros (plus Spanish VAT)** per square metre or part thereof, and the ground floor space underneath will be charged at the basic stand rental charge of **200 euros (plus Spanish VAT)** per square metre or part thereof. The second storey is not subject to open side surcharges.

This first payment will be refunded if the applicant is not admitted to the exhibition (see “General Regulations”, Articles A8.1, A8.2), but will be forfeited if unilaterally the applicant withdraws totally from the undertaking (for partial withdrawals, see “General Regulations”, Articles A12.4, A12.5, A12.6), or if the Rental Contract is terminated prematurely (see “General Regulations”, Articles A8.4, A8.6).
